# Contribution of Legal Services towards India's GDP

A series of cross country econometric studies systematically reveal the importance of legal rules. They claim that legal origins are centered to understanding the divergence in living standards across regions and countries worldwide. <u>Law plays a very significant role in the development of a nation's GDP.</u> While the contribution of legal services to India's GDP is currently modest at 1-2%, it is crucial in supporting economic activities. This sector has significant potential for growth, and by focusing on customer service areas, it can increase its contribution to the national GDP while also enhancing overall economic growth and access to justice.

While the available data doesn't explicitly state the contribution of Law to the Indian GDP, it's crucial to recognize this sector's potential. Among the sectors contributing to India's GDP, the service sector is the most significant contributor at 54.86%, followed by the industry sector at 27.55% and the agriculture sector at 17.59%.

Within the service sector are various sub-sectors, including Financial Services, Real Estate, and Professional Services, which include legal services. The service sector's contribution is:

Primary (Agriculture, Forestry, Fishing, and Mining & Quarrying): 21.82% Secondary (Manufacturing, Electricity, Gas, Water Supply, etc.): 24.29% Tertiary (Services-including <u>Legal Services</u>): 53.89%

The salient strategies to Increase the contribution of Legal Services to GDP are as follows:-

#### **Digital Transformation:**

One key strategy to increase the contribution of Legal Services to GDP is through digital transformation. Implementing technology in legal practices can streamline operations and reduce costs. Online Dispute resolution, e-filing, and legal tech startups can significantly enhance efficiency.
